Nominations are invited for the election of **one** parent representatives to the School Board. These positions will be until September 2025.

There are two ways to put forward a nomination for your school Board. You can either use our school Election Portal or send completed documentation directly to CES via email or post.

### OPTION 1 - SCHOOL ELECTION PORTAL

We have created a school specific Election Portal for you to enter your nomination, provide a Candidate Statement and submit a photograph.

### OPTION 2 – EMAIL, POST OR DELIVERED TO SCHOOL

Please use the following instructions for submitting both your Nomination Form and Candidate Statement. Note the email and postal address below.

#### Nomination Form

We have enclosed a Nomination Form to enable you to put your name forward, or to nominate someone as a candidate.

- Complete the Nomination Form, including the necessary signatures.
- Complete the candidate's contact details, including both address and telephone number (home and mobile).

#### Candidate Statement

As a candidate, you are invited to submit a brief (up to 350 words) statement.

- Ensure you include the MOE School Profile Number and your school's name.
- Commence your profile by stating "My name is ----- and I am standing for the ----- School Board."
- *We will omit or abridge any Candidate Statement that exceeds 350 words.*

Nominations close at **12 noon on Friday, 19th August 2022**. Nomination Forms and any Candidate Statements must be in the hands of the Returning Officer by this time. Please be aware of NZ Post timeframes if posting documents. **Late Nomination Forms and Candidate Statements will not be accepted.**

**It is the candidate's responsibility to ensure the Nomination Form and Candidate Statement are received by CES. To confirm this, please phone the Returning Officer Team on (03) 338 4444.**

#### **VOTING ROLL**

A copy of the voting roll is available for inspection at the school office during normal school hours.

#### **ELIGIBILITY**

Anyone may stand for election for the School Board. However, if you are not a parent of the school, a parent who is on the voting roll must nominate you. **If you are a school staff member then you cannot stand as a parent representative.** Please check the eligibility conditions on the reverse of the Nomination Form.

#### **VOTING AND RESULTS OF THE ELECTION**

If the number of nominees is the same as, or less than, the number of vacancies then the nominees will be declared elected, and no election will be required. If there are more nominations than vacancies for Parent Representatives, eligible voters will be sent Voting Papers and Candidate's Statements (where provided) by Friday, 26th August 2022.

Voting closes at 4pm on Friday 23rd September 2022. As per statutory requirements, vote counting will commence on Thursday, 29th September 2022. The highest polling candidate(s) will be elected to the School Board. The results of the election will be published in the school newsletter. Nomination Forms are available in Maori, please contact CES if these are required.

## People who are not eligible to be school board members

The following people are not eligible to be school board members.

A person who:

- is an undischarged bankrupt; or
- is prohibited from being a director or promoter of, or being concerned or taking part in the management of, an incorporated or unincorporated body under the [Companies Act 1993](#), or the [Financial Markets Conduct Act 2013](#), or the [Takeovers Act 1993](#); or
- is a permanently appointed member of the Board staff, unless they are standing for election as a staff representative; or
- contracts or sub-contracts with the Board without the approval of the Secretary of Education and receives payments exceeding \$25,000 in any financial year. This would also cover situations where a person has a 10% or more shareholding in the contracting company or a company that controls the contracting company; or
- is subject to a property order under the [Protection of Personal and Property Rights Act 1988](#); or
- is a person in respect of whom a personal order has been made under that Act that either the person is not competent to manage his or her own property affairs, or does not have the capacity to communicate/make decisions relating to his/her welfare/personal care; or
- is a person who has been convicted of an offence punishable by imprisonment for 2 years or more, or who has been sentenced to imprisonment for any other offence, unless that person has obtained a pardon, served the sentence, or otherwise suffered the penalty imposed on the person; or
- is not a New Zealand citizen, **and** is –
  - a person to whom [section 15](#) or [16](#) of the Immigration Act 2009 applies; or
  - a person obliged, by or pursuant to that Act, to leave New Zealand immediately or within a specified time, being a time that was less than 12 months; or
  - deemed for the purposes of that Act to be in New Zealand unlawfully.

A returning officer for an election (or by elections) of board members is not eligible to be nominated as a candidate in that election.
